The Indian Legal Documents collection contains court records from several former princely states in the present-day state of Rajasthan, dating primarily from the 1930s and 1940s. Each document bears an official stamp reflecting location and related court fees. Records are all hand-written in a variety of scripts; languages are primarily Hindustani and Urdu. Locations, as stated on document stamps, include Bundi, Jaipur, Jodhpur, Khetri, and Tonk.
